Sub: Prayer for starting a specific case.

Sir,

In producing here with the following arrested accused persons namely 1. Sk. Saifullah (20) S/O Sk. Majed Ali of Vill- Dighasipur, PS- Bhabanipur, 2. Sk. Sanwar Ali@ Bhombol (21) S/O Sk. Sahajamal of Vill- Dighasipur, PS Bhabanipur and 3. Sk. Maidul Islam (22) S/O Aminul Islam of Vill- Dighasipur, PS Bhabanipur all of District Purba Medinipur along with seized articles i.e. 1. One knife made of iron approx 10 inches in length seized from the right side pant pocket of accused Sk. Saifullah 2. One Bhojali made of iron approx 1 ft in length seized from the right hand of accused Sk. Sanwar Ali @ Bhombol and 3. One iron rod approx 3 ft in length seized from the right hand of accused Sk. Maidul Islam I ASI Asit Kumar Panda beg to report that on 15.05.17 at about 03.05 hrs, while I was performing mobile duty with C/1237 Khokon Adhikary and C/ 668 Prasanta Mishra vide Bhabanipur PS CC NO. 1280/17 dt. 14.05.17, received an information from duty officer SI Samir Mukherjee that some miscreants gathered in a bush area opposite of Esser Petrol Pump at Link Road near Matangini Morh in order to commit dacoity at the said petrol pump. Accordingly I consulted with O/C Bhabanipur PS and left for the PO to work out the information.

On 15.05.17 at 03.25 hrs I along with force reached near the PO mentioned above and found some numbers of unknown miscreants were gossiping among themselves at the P.O in the darkness. On seeing the police party the miscreants tried to flee away but after a hot chase we managed to apprehend the above noted arrested accused persons and some of them flew away from the spot on their Motor Cycles. The apprehended accused persons on interrogation disclosed their identity as noted above and stated that they were assembled at the PO for committing dacoity at the Esser Pertol Pump. They also stated that another 7 persons were with them to commit the crime who flew away from the spot sensing the presence of police on motor cycles. On interrogation the accused persons stated that if they get chance they would help police to trace the other associates and co accused relating to this crime. On suspicion we searched them and found the above noted seized articles from them. I seized the above noted articles under proper seizure list duly signed by the witnesses. I accordingly arrested the apprehended accused persons after issuing them proper memo of arrest and telling them their ground of arrest.

Hence, I pray before you to start a under proper section of law against the apprehended arrested accused persons and oblige.
