Baruttarkingly, some unknown miscreant/miscreants threw any hard substance aiming his vehicle and broken the front glass of the vehicle. Hence, On return to the P.S. I started Bhubanipur P.S. Case No. 117/17 dated 22.05.17 u/s 341/307/427/120B IPC & 3 P.D.P.P. Act against unknown miscreant/miscreants on suo-moto. I took all informative actions. SI. Raja Mondal in. please investigate the case.
