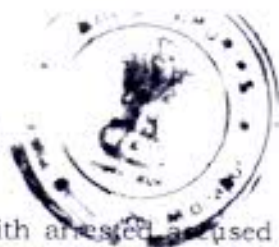

In producing herewith arrested accused person namely Sk. Matibul (21 yrs.), s/o- Sk. Safijuddin of vill- Kanchanpur Jalpai, PO- Keshabpur Jalpai, PS- Mahisadal, Purba Medinipur along with seized articles i.e i) 05 (five) nos. of iron made barrels loaded with petroleum product each capacity of 200 (two hundred) ltrs. total approximately 1000 (One thousand) Ltrs. and ii) 01(one) Ltr of petroleum product taken from the above container/barrels as sample for its examination and opinion.

I SI, Dilip Kumar Das of DEB, Purba Medinipur do hereby lodged a written complaint against the accused person namely Sk. Matibul (21 yrs.), s/o- Sk. Safijuddin of vill- Kanchanpur Jalpai, PO- Keshabpur Jalpai, PS- Mahisadal, Purba Medinipur to the effect that today (20.01.17) received a secret source information regarding illegal/ clandestine business, storing and selling of petroleum product at Kasthakhali, near Hi-Tech Engineering, beside NH-41 under PS Bhabanipur. After inform the matter to Dy. SP, DEB, Purba Medinipur and as per instruction myself along with ASI Tapas Paul, WC-159 Suvendu Manik, WC-291 Rabindranath Bari of DEB Purba Medinipur left for Bhabanipur PS and after reaching at Bhabanipur PS informed the matter to OC, Bhabanipur PS and requested to render police assistance. After that we alongwith ASI Asit Kr. Ponda, C/ 856, Sadhan Bose, C/1711, Tapan Kr. Ghorai of Bhabanipur PS left for PO to work out the source information after noting in Bhabanipur P.S GDE NO.795 dt. 20.01.2017. At 15.35 hrs. when we reached at the P.O, we found that some persons are selling petroleum products from the makeshift godown. On a hot chase we are managed to apprehend one person while some other miscreants managed to flee away from there. On interrogation the apprehended person disclosed his identity namely Sk. Matibul (21 yrs.), s/o- Sk. Safijuddin of vill- Kanchanpur Jalpai, PO- Keshabpur Jalpai, PS- Mahisadal, Purba Medinipur. He also confessed that he is owner of the said illegal business. Then I asked him to produce valid papers / license in support of such business as well as storing and selling of the petroleum product, but he failed to produce any paper in support of selling/storing of petroleum products. Accordingly, after lapse of reasonable time in presence of available witnesses namely i) Sanjib Roy(24yrs.), s/o- Netai Roy of Mandirpara, PO- Maheshtala Dakghar, PS- Maheshtala, presently residing at Barsundra under PS- Bhabanipur ii) Md. Allauddin (27 Yrs.) s/o- Md. Majer Hossain of 4/3H/13/1 B.K. Road, Kolkata 23, presently residing at Barsundra under PS- Bhabanipur the following articles were seized after preparing proper seizure list dully signed by the witnesses and took signature of accused person. Seized articles are as follows i) 05 (five) nos. of iron made barrels loaded with petroleum product each capacity of 200 (two hundred) ltrs total approximately 1000 (One thousand) Ltrs. and ii) 01(one) Ltr of petroleum product taken from the above seized barrels as sample for its expert examination and opinion. The seized articles kept at Bhabanipur PS compound.

On interrogation the apprehended person confessed that the said illegal business is running by himself without any valid papers from the competent authority. As such I arrested Sk. Matibul (21 yrs.), s/o- Sk. Safijuddin of vill- Kanchanpur Jalpai, PO- Keshabpur Jalpai, PS- Mahisadal, Purba Medinipur after observing all formalities and informed him ground of arrest, as he is violated section 3(d) of Essential Commodities Act X/55 and he is liable for prosecution under section 7(i)a(ii) of Essential Commodities Act X/55.

After returning at the PS along with arrested accused person and seized articles and submitting a written complaint to start a specific case against the accused persons namely Sk. Matibul (21 yrs.), s/o- Sk. Safijuddin of vill- Kanchanpur Jalpai, PO- Keshabpur Jalpai, PS- Mahisadal, Purba Medinipur under section 7(i)a(ii) of Essential Commodities Act X/55 for investigation.
