1. 42 pieces of bricks/ Stones in different shape.
2. Portion of broken glass of street light.
3. Portion of broken glass of windows of Bhabanipur PS Malkhana.
4. Broken part of drinking water pipe line of Bhabanipur PS.
5. 12 pieces of wooden/bamboo sticks in different size.
6. One Dhal having blood stain issued against C/1237 Khokon Adhikary.
7. One Helmet having blood stain issued against C/1237 Khokon Adhikary
8. One old and used red coloured Hero Splender Pro Motor Cycle bearing regd no. WB30T-0945.
9. One old and used white and blue coloured Yamaha F2S Motor Cycle bearing regd no. WB30D-9063.
10. One old and used red coloured Yamaha Motor Cycle bearing regd no. WB30M-2261.
11. One old and used black coloured Honda Yoga Motor Cycle bearing regd no. WB30T-2325.
12. One old and used black and blue coloured Bajaj Discover Motor Cycle bearing regd no. WB30S-7794.
13. One old and used black coloured SPL-NXG Motor Cycle bearing regd no. WB30M-9369.
14. One old and used black coloured Bajaj Pulsar Motor Cycle bearing regd no. WB30B-8318.

All the above motor cycles were brought by the accused persons when they came to the PS.

I SI Gopal Pathak, O/C Bhabanipur PS do hereby lodge a written complaint to the effect that on 21.06.17 at about 03.00 hrs a dead body of one Salman Khan (21 years) S/O Abdul Mabud Khan of Barghashipur, PS Bhabanipur was found floating in a pond situated at Barghashipur opposite of his house who was missing since 19.06.17 night. On the basis of the written complaint of Abdul Mabud Khan, Bhabanipur PS case NO. 143/17 dated 21.06.17 U/S 302/201/120B IPC was started against six suspects over the death of Salman Khan. SI Samir Mukherjee held inquest over the dead body and forwarded the dead body to the Superintendent of Haldia SD Hospital for PM Examination to ascertain the actual cause of death. On 22.06.17 PM examination over the dead body was done at the Medinipur Medical College Hospital. After completion of the PM examination the dead body of the deceased Salman Khan was brought to his house by his relatives. Then, at 21:05 hrs a group of irate Mob (200/250) including a good number of ladies and children equipped with wooden /Bamboo sticks, Iron Rod, Brick Bats under the leadership of 1. Sk. Anwar Hossain 2. Sk. Habibul 3. Sk. Amjad Hossain all S/O Sk. Umar Ali 4. Saddam Hossain S/O Sk. Goni all of Vill Jhikurkhali, PS Durgachak 5. Abdul Khalek Khan S/O Julias Ali Khan of Barghashipur, PS Bhabanipur 6. Sakir Ali Khan S/O Sirajul Khan of DO, 7. Sk. Sahajahan S/O Lt. Abdul 8. Sk. Akbar Ali S/O Sk. Yasin Ali 9. Sk. Mukaram S/O Sk. Hamidul 10. Sk. Ansar Ali S/O Golam Momtaj 11. Sk. Abdullah 12. Khalek Khan S/O Julias Khan 13. Abdul Mabud Khan S/O Julias Khan 14. Ayub S/O Yasin 15. Soleman 16. Mainu 17.

Anwar Khan S/O Mansur Khan of Dighashipur, PS Bhabanipur 24. Sk. Soleman of DO and 25. Mohasin Mallik S/O Siddik Mallik of DO suddenly appeared in front of the Bhabanipur PS. They also brought the dead body of Salman Khan which was lying in a dead body carrier vehicle placing the dead body in front of the PS building they started to showing agitation demanding the arrest of the alleged persons and they also started to blame Police alleging the inaction on the part of Police. I lodged a GD entry vide Bhabanipur PS GDE No. 890 dated 22.06.17. Informed CI Mahishadal, SDPO, Haldia, Addl. SP. Haldia and SP Purba Medinipur. Listened to their kind instructions then, myself along with available officer SI Raja Mondal, ASI Partha Chatterjee, ASI Rajendra Chakraborty duty officer, ASI Asit Kumar Panda, C/1237 Khokon Adhikary, C/830 Ananda Mohan Das, C/1508 Prabir Polley, Sentry Const/366 Debabrata Mondal, approached before them. Seeing us they became more violent and started to abuse and was threatening police in filthy language by uttering "SALA RA GHUS KHEYE CASE DHAMA CHAPA DICCHIS, TODER AAJ KHUN KORE FELBO, THANA JALIA DEBO ETC....." We tried to convince them request them to maintain peace but they don't bother to care. We cautioned and warned them repeatedly but they became more furious and started brick batting aiming police and PS building. A good numbers of member of irate mob started to assault Police by wooden/ Bamboo sticks aimlessly. They broke the drinking water pipe line of the PS building, windows of the Malkhana of PS, Street light on the entrance of the PS building. Whenever we chased them they started to flee away in different direction. Some of them fell down on the rocky soil sustained injuries on their persons. Following their brick batting myself along with SI Raja Mondal, ASI Partha Chatterjee, ASI Rajendra Chakraborty, C/1237 Khokon Adhikary, C/830 Ananda Mohan Das, C/1508 Prabir Polley, driver of hired vehicle Raja Kopat and Tanmoy Ponda sustained injuries. The member of irate mob assaulted C/1237 Khokon Adhikary by wooden and bamboo sticks caused his facial and head injury. Whenever reinforcement was arrived under the charge of SDPO, Haldia, the irate mob started to disperse leaving the dead body of the Salman Khan and above noted seized articles in the PS campus in scattered way being chased we could apprehend, 1. Sk. Anwar Hossain (42) S/O Sk. Umar Ali of Jhikur Khali, PS Durgachak and 2. Sk. Habibul (28) S/O Sk. Umar Ali of DO and took them into custody. Arrest was effected by issuing memo of arrest. I also seized the above noted articles under proper seizure list in presence of the witnesses duly signed by them as Alamat. The major part of the hooligan activities could have been recorded by the existing PS CCTV camera. Then, I arranged medical examination of all the injured Police Personals, driver of the hired vehicles and arrested persons. The condition of injured constable Khokon Adhikary is in precarious. So the attending MO referred him subsequently he was shifted to Kolkata for his better treatment.

Hence, under the above circumstances, I started Bhabanipur PS case No. 144/17 dated 23.06.17 U/S 148/ 149/ 186/ 323/ 325/ 326/ 332/ 333/ 353/ 307/ 427/ 506 IPC and 3 PDPP Act as Suo-Moto against the above hooligans. I took all informative actions. SI Raja Mondal will please investigate the case.
