I do hereby lodged a complaint empowered by the Electricity Act 2003 to the effect that Jamaluddin Khan, S/o-Mohammad Khan, Vill+P.o-Baruttarhingly ,P.s-Bhabanipur ,Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with amendment act 2007 as stated hereunder.

On 13.02.2017 about 1:05PM I, Dibyendu Sekhar Bhunia, DE & S&LP, Tamluk Regional office along with Gaya Prasad Ghoroi (AE & SM) of Brajalalchak CCC, Suman Kalyan Pattanayek, SAE(E), Kamal Khatua, HGSRLM, Brajalalchak CCC, & Other official had been to village Baruttarhingly for inspection purpose & we went to the domestic premises of that Jamaluddin Khan, S/o-Mohammad Khan, Vill+P.o-Baruttarhingly, P.s-Bhabanipur, Dist-Purba Medinipur

During inspection it was found that Jamaluddin Khan, S/o-Mohammad Khan, Vill+P.o-Baruttarhingly, P.s-Bhabanipur, Dist-Purba Medinipur was consuming electricity by the way of direct hooking from nearest L.T.O.H line dishonestly for his wrongful gain for less recording of energy to energy meter at a tune of load of 0.73 KVA, causing loss of revenue of W.B.S.E.D.C.L. During local enquiry as well as official records the fact revealed that Jamaluddin Khan, S/o-Mohammad Khan, Vill+P.o-Baruttarhingly, P.s-Bhabanipur, Dist-Purba Medinipur is a consumer of W.B.S.E.D.C.L reference ID no-224003203 and meter no-L1157814

As the theft of electricity was detected during the inspection, the service connection was disconnected &the unauthorized wire was removed. Some portion of single core P.V.C. wire (white colour) approx 10Mt along with hooking device & one yellow card sl. No-3653353 in the name of Jamaluddin Khan were seized under a memo of seizure list in the presence of witnesses and their signature is duly obtained in the seizure list. The above P.V.C. wire with hooking device & yellow card were duly packed and labeled at the inspection site and signature of witnesses also obtained on the label. I also prepared an inspection report at site with duly signed by the witnesses. After completion of all formalities, we left the premises at 1:30PM.

Thus the accused Jamaluddin Khan, S/o-Mohammad Khan, Vill+P.o-Baruttarhingly ,P.s-Bhabanipur ,Dist-Purba Medinipur has committed theft of energy U/S 135/(i)(b) of the Electricity Act 2003 read with Amendment act 2007 by way of direct hooking for less recording of energy to the energy meter.

Under this circumstance you are requested to take cognizance of this complaint & treated the same as F.I.R.
