Dear sir,

This is to inform you that a mishap has occurred at Barghashipur BPHC on 11th FEBRUARY 2017 at evening. Our GDA staff Ram Prasad Bhakta who stays very near to BPHC informed me over telephone that an unused quarter of BPHC was set on fire by some unknown person. We informed you about the matter over telephone and the fire was extinguished by fire brigade. Next day morning Ram Prasad again informed me over telephone that lock of backdoor of our cold chain room (where the vaccines are stored) was broken down and three stabilizers of ILR and deepfreeze ,one ceiling fan were stolen.

I would there fore request you to kindly enquire the matter and file a GD for above mentioned incident. Thanking you.
