Today on 26.02.2017 at about 23:25 hrs I SI Kalyanbrata Majumder of Bhabanipur PS along with C/366 Debabrata Mondal and C/668 Prasanta Mishra had been to Kumarpur to assist LSI Anuska Maity of Haldia Women PS and her force namely LC/1459 Ruksana Khan, LC/1845 Sujata Bera for holding raid against one Sk. Obaydulla S/O- Alfazuddin of Vill- Kumarpur PS- Bhabanipur Dist- Purba Medinipur along with other two co-accused persons namely Sk. Basar S/O- Lt. Sk. Abu Saley and Sk. Salfulla S/O- Sk. Saley all of Vill- Kumarpur PS- Bhabanipur Dist- Purba Medinipur in c/w Haldia Woman PS Case No. 18/17 Dated. 26.02.2017 US- 448/341/354/354A/354B/354D/323/506/34 IPC at his residence maintaing all norms and conditions. Arrest was almost done as shown by the complainant namely Mabuda Bibi W/O-Samsuddin Mir of Kumarpur PS-Bhabanipur Dist- Purba Medinipur but in the certain time under the leadership of Panchayat Member one Rafikul Islam Khan@Khokan S/O- Mahammad Khan of Kumarpur PS- Bhabanipur along with others mostly female members unlawfully assembled and cordoned the police vehicle and police personnals. I asked them to do our government duty but the agitators did not pay any heed and continuing their subversive activity. I SI Kalyanbrata Majumder and accompanied force tried to pacify the unlawful gathering created chaos and tension but in vain. At that time the FIR named accused persons were snatched away from our grip becoming violent and started pelting stones to us, also used fist and blows, bitten by bamboo sticks and Iron rod causing injury to us with a view to attempt to murder. Torn off flap with stars of my Uniform with Uniform and nameplate. Outrage female modesty and also torn off uniform of Lady constable /1845 Sujata Bera of Haldia Woman PS which are still remain at the house of accused Sk. Obaydulla S/O- Lt. Sk. Alfazuddin of Vill- Kumarpur PS-Bhabanipur Dist- Purba Medinipur. In this situation requested for reinforcement. But the mob did not pay any heed to our plea . By this time myself along with whole police team however managed to escape from the place with grievous injury and shifted the injured police personals including me to Haldia Sub-Divisional Hospital (Durgachak) for treatment. Myself along with Lady constable /1845 Sujata Bera of Haldia Woman PS received serious injury. Myself and other injured forces were treated at Haldia Sub-Divisional Hospital (Durgachak).

Hence I, SI Kalyanbrata Majumder of Bhabanipur PS prayed to yourself for lodging a case against the aforesaid accused persons namely (1) Rafikul Islam Khan@Khokan S/O- Mahammad Khan (2) Sk.
