With due respect, I beg to state that our LPH Bottling plant in your jurisdiction started our production in August 2016. We receive LPH in Bulk Tank Tankers (TANKERS), unload and refill cylinders and issue to transporters to provide to Distributors.

On our inspection period our LPH Bottling Plant, we found that shortage of 22 MT LPH Bulk and 64 PLS of 14.2 kg LPH cylinders. Then we did an investigation and finding from our staff. We found out that 1) Filling labour Rinku, 2) Driver - Ganesh Mondal & 3) Security Guard - Santan Bera were involved with some miscreant associated our staff.

Hence we request your kind self to take necessary ^{legal} immediate action at the earliest.
