Dear Sir,

I Sri Dipen Chatterjee, S/o Mukul Chatterjee presently posted as Assistant Engineer (Technical-I), Haldia Division, WBSEDCL is to inform you that a rail pole of the newly commissioned 11 KV Tentulberia feeder was damaged and dislodged from its point of erection due to falling of a vehicle (oil tanker) bearing Vehicle No. NL01N 4590 from the Link Road to the road side causing snapping of LT wires along with uprooting of the existing 11 KV rail pole.

The driver and helper of the said vehicle fled from the spot.

The above incident occurred at around 03:30 hrs today and caused considerable loss to WBSEDCL and resulted in unwanted power interruption too.

The estimated repairing cost of the damaged portion comes to the tune of Rs 60000/- (Rupees Sixty thousand only) approximately.

As this incident caused considerable loss to WBSEDCL this letter may kindly be treated as FIR and necessary lawful action be taken accordingly.
