During inspection it was found that Manoj Samanta, S/o-Lt. Ramhari Samanta, Vill+P.o-Basanchak, P.s-Bhabanipur, Dist-Purba Medinipur was consuming electricity by the way of direct hooking from nearest L.T.O.H line dishonestly for his wrongful gain for less recording of energy to energy meter at a tune of load of 1.20 KVA, causing loss of revenue of W.B.S.E.D.C.L.
