Dear Sir,

I do hereby lodged this written complaint empowered by the Electricity Act 2003 read with amendment act 2007 against one Sk. Safibul, S/o-Lt Sk. Askar, Vill-Kasthakhali, PS- Bhabanipur, Dist- Purba Medinipur has committed theft in respect of Electricity u/s 135 of the Electricity Act 2003 read with amendment act 2007 as stated hereunder.

On 19.04.2017 at about 4:10 pm I, Gaya Prasad Ghoroi, AE&SM, Brajalalchak CCC, along with Suman Kalyan Pattanayek (S.A.E) of Brajalalchak CCC, Kamal Khatua, HRSRLM, Brajalalchak CCC, Ajit Sharma, LM, Brajalalchak CCC, & other official had been to the Domestic Premises of one Sk. Safibul, S/o-Lt Sk. Askar, Vill-Kasthakhali, PS- Bhabanipur, Dist-Purba Medinipur for inspection purpose.

During inspection it was found that Sk. Safibul, S/o-Lt Sk. Askar, Vill-Kasthakhali, PS- Bhabanipur, Dist-Purba Medinipur was consuming electricity by the way of direct hooking from nearest L.T.O.H. line dishonestly & unauthorizedly for domestic purpose at a tune of load of 0.3 KVA, causing loss of revenue of W.B.S.E.D.C.L.

As the theft of electricity was detected during the inspection, the unauthorized wire was removed. Some portion of single core P.V.C. wire (yellow colour) approx 3 Mt each along with hooking device was seized under a memo of seizure list in the presence of witnesses and their signature is duly obtained in the seizure list. The above P.V.C. wire with hooking device was duly packed and labeled at the inspection site and signature of witnesses also obtained on the label. I also prepared an inspection report at site with duly signed by the witnesses. After completion of all formalities, we left the premises at 4:25 PM

Thus the accused Sk. Safibul, S/o-Lt Sk. Askar, Vill-Kasthakhali, PS- Bhabanipur, Dist-Purba Medinipur has committed an offence u/s 135(1)(a) of electricity act 2003 read with amendment act 2007 for commission of theft in respect of electricity by way of direct hooking from nearby LTOH line.

On the above fact and circumstances you are requested to take cognizance and treat the same as FIR
