Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Nishikanta Barman, S/O- Lt Ram Barman of Vill: & P.O- Gurgram, P.S- Bhagwanpur, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 16.05.2017 at about 01:30 PM, I, Sri Manas Maity, A.E.(U), Sri Pradip Kr Chakraborty, SO both are of (S&LP) unit Contai Division Office, along with Sk Abdul Sanower, SAE (E) Bhagwanpur CCC, Sri Sanjib Kr Mistri, LM Bhagwanpur CCC and others had been to the Vill: Gurgram, P.S- Bhagwanpur for routine inspection purpose. At first we went to the Domestic premises Sri Nishikanta Barman, S/O- Lt Ram Barman of Vill: &, P.O- Gurgram, P.S- Bhagwanpur, Dist- Purba Medinipur and during inspection it was found that Sri Nishikanta Barman, S/O- Lt Ram Barman of Vill: Gurgram under P.S- Bhagwanpur, Dist- Purba Medinipur consuming electricity unauthorisedly to the Commercial big Fishery situated adjacent to his house by the way of direct hooking for meter bypassing in respect of Consumer Id No: 223070792, Meter No: B3104668, through single core stranded 7/16 SWG, white colour PVC coated aluminium conductor in view of less recording of unit or energy in to the energy meter, also change the purpose of use of electricity from Domestic to Commercial causing loss of revenue to WBSEDCL in the tune of load 2.980 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of one no single core stranded 7/16 SWG, white colour PVC coated aluminium conductor of length 3.5 (three and half) meter (approx) along with hooking device used to run the commercial fishery unauthorisedly as a sample was seized under memo of seizure list in presence of representative of the consumer i.e. Sri Netai Barman S/O- Sri Nishikanta Barman and witnesses and duly signed by the witnesses. Sri Netai Barman S/O- Sri Nishikanta Barman was present at the inspection site but intentionally refused to sign on the Inspection Report, Seizure List & as well as on the Label also. Thereafter the seized articles were packed and labeled at the inspection site in presence of Sri Netai Barman S/O- Sri Nishikanta Barman i.e. representative of the consumer and witness and signature of witnesses obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 02:00 PM.

Thus Sri Nishikanta Barman, S/O- Lt Ram Barman of Vill: &, P.O- Gurgram, P.S- Bhagwanpur, Dist- Purba Medinipur has committed an offence u/s 135 (i) (b) & (e) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
