Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Joydeb Jana, S/O - Lt Iswar Jana, a permanent resident of Vill- Paschim Ghoshpur, P.O - Naba Anantapur, P.S -Bhagwanpur, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 10.01.2017 at about 01:30 PM I, Sri Manas Maity, A.E.(U), Sri Pradip Kumar Chakraborty, SO all are of (S&LP), Contai Division Office along with Sri Indranil Maji, AE & SM, Bhagwanpur CCC, Sri Sanjib Kr Mistri, LM Bhagwanpur CCC and others had been to the village- Satupur for routine inspection purpose. During inspection it was found that Sri Joydeb Jana was consuming electricity dishonestly in his Commercial premises namely Maa Hosiery unauthorisedly by way of direct hooking from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 2.34 KVA.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of two core, round shape 600/1100 Volt grade 6 sq mm black colour PVC coated aluminium cable of length 3 (three) meter (approx) along with hooking device used to run the electrical appliances for Commercial purpose has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Tapas Kr Achar S/O- Lt. Subhas Ch. Achar representative of the accused was present during inspection & acknowledged the same by putting his signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as the representative of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 02:00 PM.

Thus the accused Sri Joydeb Jana, S/O - Lt Iswar Jana, Vill - Paschim Ghoshpur, P.O - , P.S -Bhagwanpur, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
