Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Naba Kr. Panda, S/O - Nityananda Panda, a permanent resident of Vill-& P.O -Bibhisampur, P.S -Bhagwanpur, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated here under.

On 12.06.2017 at about 01:00PM I, Sri Manas Maity, A.E.(U), Sri Pradip Kr Chakraborty, SO both are of (S&LP) unit Contai Division Office along with Sri Indranil Maji, AE & SM, Bhagwanpur CCC, Sri Sounak Kar, LM Bhagwanpur CCC and others had been to the village- Bibhisampur for routine inspection purpose. During inspection it was found that Sri Naba Kr Panda was consuming electricity dishonestly in his Domestic premises unauthorisedly by way of direct hooking from the nearby LTOH line of WBSEDCL through 2 nos separated white colour PVC coated conductor, causing considerable loss of revenue of WBSEDCL to the tune of load 0.700 KVA.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and Some portion of 2 nos separated white colour PVC coated out of one no single core 3/20 SWG copper another one single core 7/20 SWG aluminium cable of length 2 meter each approx along with hooking device used for hooking from the LTOH line of WBSEDCL as a has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Naba Kr Panda acknowledged the same by putting his signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 01:30 PM.

Thus the accused Sri Naba Kr Panda, S/O - Nityananda Panda, Vill - & P.O - Bibhisampur, P.S -Bhagwanpur, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
