Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Hiranmay Panda, S/O - Lt Bishnupada Panda, a permanent resident of Vill-Bibhisnanpur, P.O -Bibhisnanpur, P.S -Bhagwanpur, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 12.06.2017 at about 02:05 PM I, Sri Indranil Maji, AE & SM, Bhagwanpur CCC along with Sri Manas Maity, A.E.(U), Sri Pradip Kr Chakraborty, SO both are of (S&LP) unit Contai Division Office, Sri Sounak Kar, LM Bhagwanpur CCC, Sri Sarbeswar Sing, TSH Bhagwanpur CCC and others had been to the village- Bibhisnanpur for routine inspection purpose. During inspection it was found that Sri Hiranmay Panda was consuming electricity dishonestly in his Domestic premises unauthorisedly by way of direct hooking from the nearby LTOH line of WBSEDCL through 2 nos separated white colour PVC coated 7/20 SWG aluminium cable, causing considerable loss of revenue of WBSEDCL to the tune of load 0.200 KW.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of 2 nos separated white colour PVC coated 7/20 SWG aluminium cable of length 1.5 meter each approx along with hooking device used for hooking from the LTOH line of WBSEDCL as a sample has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Hiranmay Panda refused to sign in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 02:30 PM.

Thus the accused Sri Hiranmay Panda, S/O - Lt Bishnupada Panda, Vill - & P.O - Bibhisnanpur, P.S -Bhagwanpur, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
