Sir,

In producing herewith the arrested accused namely Dr. R.K.Mondal @ Dr. Rabindra Kumar Mondal @ Ruhul Kuddush (55 years) S/O Late Akbar Ali of Bhabanipur, Post Ghosalati, PS Hasnabad, Dist 24 Parganas( North) , along with the seized articles as per seizure list. I SI Tapas Kumar Ghosh of Bhagwanpur PS do hereby lodging a complaint to the effect that on 17.06.17 during evening mobile duty at PS area with C/289 Jayanta Dolai and NVF Shyamapada Manna at about 19:15 hrs duty officer ASI Arunanshu Bar received a telephonic information and informed me over phone that some local people of Bhimeswari Bazar apprehended one person who is said to be MBBS Doctor R. K.Mondal. But people found him deleting his name from the outside wall of his chamber at Bhimeswari Bazar where he is written as Dr. R.K. Mondal , MBBS,DGO(Cal) and tearing his prescription pad. Accordingly myself alongwith force rushed to the spot.

At about 19:35 hrs myself alongwith reached at the spot and found that some local people of Bhimeswari Bazar apprehended one person namely Dr. R.K.Mondal. On asking local people stated that the apprehended person was personating himself as an MBBS doctor and was running his chamber for last five months here in a rented room of Matanghini Pharmacy at Bhimeswari Bazar. On 17.06.17 at evening said doctor removed his name and designation which was written on outside wall of his chamber at Bhimeswari Bazar and was trying to escape from that place. Accordingly I interrogated the apprehended person whether he is an MBBS doctor but he gave no reply and became completely speechless and later disclosed his identity as Dr. Rabindra Kumar Mondal and on further interrogation disclosed his identity as Ruhul Kuddush (55 years) , S/O-Late Akbar Ali of Bhabanipur, Post- Ghosalati, PS Hasnabad, Dist- 24 Parganas( North). On demand he could not be able to produce any documents or certificate regarding his MBBS degree. Thereafter, I searched his chamber found some blank pad / prescription where the name Dr. R.K. Mondal,

MBBS, DGO, MD (Cal) is printed. On prolong interrogation he confessed that he is not an MBBS doctor and someone guided him to use MBBS degree . He confessed before people gathered there that he is graduate in science and with the help of some brokers he obtained forged certificate and started using that certificate as genuine for the last two years. He further stated that he is practicing as Gynaecologist and obstetricians with this forged degree and seals. He used to charge Rs.250/- as his fees per patient. As his activities disclosed the commission of offence punishable u/s 419/420/465/467/468/471/472/ 120B IPC , so I arrested him and seized his prescription pad, his rubber stamp with his name and degree engraved on it, some doctor's kit under proper seizure list.

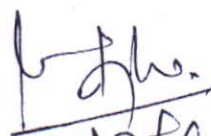
