Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sk Osman, S/O - Lt. Fazlur Rahaman, a permanent resident of Vill-Dhalbarh, P.O -Uttar Kothbarh, P.S -Bhagwanpur, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 27.06.2017 at about 11:00 AM I, Sri Indranil Maji, AE & SM Bhagwanpur CCC along with Sri Manas Maity, A.E.(U), (S&LP), Contai Division Office, Sri Sounak Kar, LM Bhagwanpur CCC and others had been to the village- Dhalbarh for routine inspection purpose. During inspection it was found that Sk Osman was consuming electricity dishonestly in his Domestic premises unauthorisedly by way of direct hooking from the nearby LTOH line of WBSEDCL through two core round shape black colour PVC coated 6 sq mm aluminium conductor, causing considerable loss of revenue of WBSEDCL to the tune of load 0.600 KVA.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of two core round shape black colour PVC coated 6 sq mm aluminium conductor of length 1 (one) meter approx along with hooking device used to run the electrical appliances by the way direct hooking from the LTOH line of WBSEDCL has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sk Maidul S/O- Sk Osman acknowledged the same by putting his signature in the Seizure List, Inspection Report while conducting inspection. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as the representative of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 11:30 AM.

Thus the accused Sk Osman, S/O - Lt Fazlur Rahaman, Vill - Dhalbarh, P.O -Uttar Kothbarh, , P.S -Bhagwanpur, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
