In returning herewith with arrested accused persons namely i) Sk. Abadulla(27) S/O- Abdul Motleb of Bhimchak, ii) Sk. Sultan(18) S/O- Sk. Mofizul of Bhimchak , iii) Sk. Mostafa(46) S/O- Sk. Bahajuddin of Bhimchak, iv) Sk. Shiraj Ali(23) S/O- Sk. Enamul of Betulichaklalpur and v) Sk. Asbauddin (54) S/O- Sk. Mohammad Ali of Lalpur and vi) Sk. Enamul(54) S/O- Daud Ali of Betulichaklalpur, all of PS- Bhagwanpur, Dist-Purba Medinipur alongwith seized articles and all relevant papers. I SI Manoj Kumar Jha, O/C Bhagwanpur PS do hereby lodging a complaint as a suo-moto to the effect that on 28-6-17 at 08:25 hrs received information from PSI Pronob Roy of Bhagwanpur PS who was on mobile patrolling duty that a chaos is going on at Gandhi Road, Lalpur. He further stated that he tried to disperse the mob by giving warning to disperse them immediately but in vain. The mob after hearing the warning become furious and started pelting brick bats and stones on police party and some of police personnel sustained minor injuries. Accordingly myself alongwith SI Biswajit Mondal, ASI Sudarshan Chandra Mondal, Const/1166 Kamal Pal, Const/147 Akshay Koley, Const/812 Biswajit Kar, LC/1478 Santoshi Mondal and LC/1481 Aruna Maity after informing my superior officers left for Lalpur to work out information. After reaching at Lalpur at about 08:45 hrs, myself found that about 150 persons divided into two groups armed with lathi, iron-rod, sword hurling bomb on each other with a view to kill the opposite group. Myself warned the mob to disperse immediately but they keeping hurling bomb, brick bats and soft drink bottles against each other. As a result of it the vehicular movement on Egra-Bajkul pitch road was stopped and a panic was created in the area. The mob also damaged some shops on the both sides of Lalpur Bus Stand and put wooden log on the road to paralyse the traffic. When police tried to pacify them and tried to clear the road, the mob again obstructed us in discharging our duty and keep pelting stones on us. Myself warned the mob to disperse immediately from there but they did not pay any heed to warning. Thereafter myself alongwith police party chased the mob and they fled away from there. Again at about 13:35 hrs, they assembled on the both side of Egra-Bajkul road near Lalpur Bus Stand started bombing against each other. The mob frequently unlawfully assembled in groups at different points on the road as well as inside Betulichaklalpur and Bhimchak villages. On getting the reinforcement, myself alongwith police party chased the mob again and arrested six members of the mob. We tried to apprehend others but they managed to fled away through muddy field. On interrogation the arrested persons disclosed their names and address as i) Sk. Abadulla(27) S/O- Abdul Motleb of Bhimchak, ii) Sk. Sultan(18) S/O- Sk. Mofizul of Bhimchak, iii) Sk. Mostafa(46) S/O- Sk. Bahajuddin of Bhimchak, iv) Sk. Shiraj Ali(23) S/O- Sk. Enamul of Betulichaklalpur and v) Sk. Asbauddin (54) S/O- Sk. Mohammad Ali of Lalpur, vi) Sk. Enamul(54) S/O- Daud Ali of Betulichaklalpur, all of PS- Bhagwanpur, Dist-Purba Medinipur. Other persons fled away from there by leaving their motor-cycle on the road. Myself seized four(04) motor-cycles, some remnants of exploded bombs, 125 pieces of brick bats as sample from 300 pieces of brick bats scattered on the road, 35 pieces of broken soft drink bottles as sample from

about 150 pieces of the broken bottles scattered on the road, eleven(11) nos. of iron-rods, nine(09) lathis and from Lalpur Bus Stand i.e the PO of the case. On further interrogation, the arrested accused persons stated that they alongwith i) Harun Rashid @ Babulal S/O-Sk. Moslem of Betuliachaklarpur, ii) Sk. Ashraf Ali S/O- Sk. Abdul Rahim of Betuliachaklarpur, iii) Masiur Rahman S/O- Moslem of Betuliachaklarpur, iv) Sk. Yakub S/o- Lt. Sk. Sahadat of Betuliachaklarpur, v) Sk. Monirul S/O-Mujit of Bhimchak vi) Azimul Hossain S/O- Abedul Islam of Betuliachaklarpur, vii) Sk. Saikul S/O- Sk. Jabbar Ali of Bhimchak viii) Sk. Rahim S/O- Lt. Jamal of Lalpur ix) Sk. Kasimuddin S/O- Sk. Soleman of Betuliachaklarpur, x) Sk. Jasimuddin S/O- Sk. Soleman xi) Sk. Monirul S/O- Sk. Pyar Mohammad, xii) Sk. Bablu S/O- Sk. Ejahar of Bhimchak xiii) Sk. Dulu S/O-Sk. Ejahar of Bhimchak xiv) Sk. Saukul @ Sukru S/O- Sk. Jaharlal of Bhimchak xv) Sk. Ekbal Mir @ Bhola S/O- Sk. Chandu Mir of Bhimchak, xvi) Sk. Abdul Rahim S/O- Jamaluddin of Betuliachaklarpur and xvii) Sk. Mantaj Ali S/O- Majahar of Bhimchak, all of PS- Bhagwanpur, Dist-Purba Medinipur were in the mob. As the activities of above arrested accused persons disclosed the commission of offence punishable u/s 147/148/149/186/332/427/307/506 IPC, 3/ 4 of The Explosive Substance Act and 9 of The West Bengal Maintenance of Public Order Act-1972 so myself arrested them.
