Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Haripada Mal, S/O- Sri Manaranjan Mal of Vill: Benauda, P.O- Mahammadpur, P.S- Bhagwanpur, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 30.01.2017 at about 02:35 PM, I, Sri Indranil Maji, AE & SM Bhagwanpur CCC along with Sri Sounak Kar, Sri Dipankar Ghosh, TSH Bhagwanpur CCC and others had been to the Vill: Benauda, P.S- Bhagwanpur for routine inspection purpose. At first we went to the Domestic premises Sri Haripada Mal, S/O- Sri Manaranjan Mal of Vill: Benauda, P.O- Mahammadpur, P.S- Bhagwanpur, Dist-Purba Medinipur and during inspection it was found that Sri Haripada Mal, S/O- Sri Manaranjan Mal of Vill: Benauda, P.S- Bhagwanpur, Dist-Purba Medinipur consuming electricity unauthorisedly by way of direct hooking for bypassing the energy consumption through the energy meter installed against con id- 223231687, Meter No: B1102394, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSEDCL in the tune of load 1.17 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of 1 (one) no. single core, 7/22 SWG yellow colour PVC coated stranded aluminium conductor of length 3 (three) meter (approx) along with hooking device used to run the electrical appliances for Domestic purpose and one yellow card vide sl no 169140 in the name of Sri Haripada Mal were seized under memo of seizure list in presence of Sri Sukdeb Mal S/O- Sri Haripada Mal and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of the son of the accused i.e. consumer and witness and signature of witnesses and representative of the consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 03:00 PM.

Thus Sri Haripada Mal, S/O- Manaranjan Mal of Vill: Benauda, P.O- Mahammadpur, P.S- Bhagwanpur, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
