Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Saktipada Das, S/O - Lt. Kanailal Das, permanent resident of Vill- Balaramchak, P.O -Ashutia, P.S -Bhagwanpur, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 02.01.2017 at about 12:30 PM I, Sri Manas Maity, A.E.(U), Sri Pradip Kumar Chakraborty, SO, both are of (S&LP), Contai Division Office along with Sri Indranil Majhi, AE & SM Bhagwanpur CCC, Sri Sounak Kar, LM Bhagwanpur CCC and others had been to the village- Balaramchak for routine inspection purpose. During inspection it was found that Sri Saktipada Das was consuming electricity dishonestly in his Domestic premises unauthorisedly by way of direct hooking from the nearby LTOH line of WBSEDCL through (one) number single core separated' stranded Blue coloured PVC coated 7/20 SWG aluminium conductor, causing considerable loss of revenue of WBSEDCL to the tune of load 0.300 KVA.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of (one) number single core separated stranded Blue coloured PVC coated 7/20 SWG aluminium conductor of length 3 (Three) meter (approx) along with hooking device used to run the electrical appliances for Domestic purpose, has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Saktipada Das acknowledged the same by putting his signature in the Seizure List Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as the representative of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 01:00PM.

Thus the accused Sri Saktipada Das, S/O - Lt. Kanailal Das, Vill - Balaramchak, P.O -Ashutia, P.S -Bhagwanpur, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
