Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Khokan Chandra Singha, S/O - Ajoy Singha, a permanent resident of Vill-Kismat Argibrah, P.O -Ektarpur, T.S -Bhagwanpur, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 08.02.2017 at about 4:00 PM I, Sri Indranil Maji, AE & S.O Bhagwanpur CCC, along with Sri Sanjib Mistri, LM Bhagwanpur CCC, Sri Jakob Hansda, TSH, Bhagwanpur CCC and others had been to the village- Kismat Argibrah for routine inspection purpose. During inspection it was found that Sri Khokan Chandra Singha was consuming electricity unauthorisedly in his Domestic premises by way of direct hooking from the nearby LTOH line of WBSEDCL causing considerable loss of revenue of WBSEDCL to the tune of load 0.471.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of 2 (two) number single core black coloured PVC coated 2.5 sqmm aluminium conductor of length 1 (one) meter (approx) each along with hooking device used to run the electrical appliances for Domestic purpose has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Khokan Chandra Singha acknowledged the same by putting his signature on the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 4:25 PM.

Thus the accused Sri Khokan Chandra Singha, S/O - Ajoy Singha, Vill - Kismat Argibrah, P.O -Ektarpur, P.S -Bhagwanpur, Dist- Purba Medinipur have committed an offence u/s 135 of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complaint treating as FIR.
