I do hereby lodge written complaint empowered by the 12 ctricity Act 2003 read with Amendment Act 2007 to the effect that Sri Bijoy Kuili, S/O - Lt Nirar jan Kuili, a permanent resident of Vill-Kismat Argibarh, P.O -Ektarpur, P.S -Bhagwanpur, Dist- Pur sa Medinipur has computted theft of Electricity u/s 135 of the Electricity Act 2003 read with Arrendment Act 2007 as glated hereunder.

On 08.02.2017 at about 4:30 PM I, Sri Indranil Maji, AE & SM Bhagwanpur CCC atons with Sri Sanjib Mistri, LM Bhagwanpur CCC, Jakob Hansda, TSH Bhagwan our CCC and others had been to the village- Kismat Argibarh for routine inspection purpose. During inspection it was found that Sri Bijoy Kuili was consuming electricity unguthorisedly in his Dome tic premises by way of direct hooking from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 0.235.

As theft of electricity was detected during inspection the illega ooking line was discount civil & removed from the nearby electrical source and some portion of 1 ( ne) number single core. Inc. coloured PVC coated 2.5 sqmm aluminium conductor of length 1 (O e) meter (approx) each load with hooking device used to run the electrical appliances for Dome tic purpose has been a good under memo of seizure list in the presence of witnesses and their sage ature is also duly abitair the seizure list. The representative of accused acknowledged the same y putting his signature Seizure List, Inspection Report. The above seized materials duly pack + and labeled at the inspsite and signature of the WBSEDCL representative as well as the remisentative of the because also been obtained on the label. After completion of inspection, the in election team in the mopremises at about 4:55 PM.

Thus the accused Sri Bijoy Kuili, S/O - Lt Niranjan Kuili, iil Kisana waganan Ektarpur, P.S -Bhagwanpur, Dist- Purba Medinipur have committed a coffence with the state of the Electricity Act 2003 read with Amendment Act 2007.
