Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Sudhir Ch. Maity, S/O- Lt. Gobinda Maity of Vill& PO: Purba Radhapur, P.S-Bhagwanpur, Dist-Purba Medinipur has committed theft of Electricity u/s.135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 02.01.2017 at about 02:00 PM, I, Sri Indranil Maji, AE & SM Bhagwanpur CCC, along with Sri Sounak Kar, LM Bhagwanpur CCC, Sri Haru Bauri, TSH Bhagwanpur CCC and Sri Manas Maity, A.E.(U), Sri Pradip Kumar Chakraborty, SO, both are of (S&LP), Contai Division Office, had been to the Vill: Purba Radhapur, P.S-Bhagwanpur for routine inspection purpose. At first we went to the Domestic premises Sri Sudhir Ch. Maity, S/O- Lt. Gobinda Maity of Vill& PO: Purba Radhapur, P.S-Bhagwanpur, Dist-Purba Medinipur and during inspection it was found that Sri Sudhir Ch. Maity, S/O- Lt. Gobinda Maity of Vill: Purba Radhapur, P.S-Bhagwanpur, Dist-Furba Medinipur consuming electricity unauthorisedly by way of tampering the service cable for bypassing the energy meter by connecting separate 2 nos Blue coloured 2.5 sq mm PVC wire in the incoming side of the energy meter in respect of Consumer Id No: 223070843, Meter No: B3781717, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSEDCL in the tune of load 1.17 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of round shape black colour PVC coated 6 sq mm 2 core tampered service cable of length 2 (two) feet approx along with bypass arrangement made by another 2 (two) nos blue colour PVC Coated 2.5 sq mm copper stranded wire used to run the electrical appliances unauthorisedly for bypassing the energy consumption through the energy meter installed against con id 223070843 and one yellow card vide sl no 1186154 in the name of Sudhir Chandra Maity were seized under memo of seizure list in presence of the representative of consumer i.e. Sri Susobhan Maity S/O- Sri Chandan Maity (grandson of the accused) and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of Sri Susobhan Maity S/O- Sri Chandan Maity and witness and signature of witnesses and representative of the consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 02:30 PM.

Thus Sri Sudhir Ch. Maity, S/O- Lt. Gobinda Maity of Vill: Purba Radhapur, P.O- , P.S- Bhagwanpur, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
