Sub: Complaints against physical assault on WBSEDCL employee at on duty hours and hampering the work of WBSEDCL

Dear Sir,

I, Sri Indranil Maji, Assistant Engineer & Station Manager, Bhagwanpur CCC, WBSEDCL do hereby lodged a written complaint against Nantu Pradhan S/O Sri Chand Hari Pradhan, Vill,-Sekhbarh, PO-Chabukia Uttarbar, P.S. -Bhagwanpur, Dist - Purba Medinipur and five associates of him for physical assault on our office staff on duty hours, forceful snatching of official documents along with them and resist in WBSEDCL work.

On 23.02.2017 at around 2.10 p.m, Sri Jakob Hansda(TSH) ,S/o- Guruprasad Hansda Vill-Krishnanagar, PO-Dhalbelun, PS-keshiary Dist-Paschim Medinipur and Sri Birpada Nayek(TSH) S/o-Pasupati Nayak ,Vill+PO-Balipal,PS-Beliaberah ,Dist-Paschim Medinipur employee of Bhagwanpur CCC was assaulted by Sri Nantu Paradhan S/O Sri Chand Hari Pradhan of Vill,-Sekhbarh and other 5 associates of him at Uttarbarh.

Sri Jakob Hansda and Sri Birpada Nayak both are TSH of Bhagwanpur CCC, went to Uttarbarh for new service connection survey of Sri Dinesh Santra and some Supervisory Meter Reading. At the time of return to Bhagwanpur CCC suddenly Sri Nantu Pradhan and five associates of him were arrived and attacked Sri Jakob Hansda and Sri Birpada Nayak without any reason with full intention of murder and also threaten for dire consequence. The accused also forcefully snatched official documents from them. They are somehow managed to escape from the place of incident. In this incident Sri Jakob Hansda bleed badly and both of them feel huge pain on their chest, head and teeth. After that incident they are admitted to Bhagwanpur Rural Hospital for primary treatment (Prescription Enclosed).

You are requested to take cognizance of this complaint and treat it as FIR for taking legal action. The FIR is typed by me.
