Dear Sir,

I do hereby lodged a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Sovaram Bhakta, S/O- Lt. Gorachand Bhakta of Vill: Haramasani, P.O- Paikvery, P.S-Bhagwanpur, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 27.02.2017 at about 03:30 PM, I, Sri Manas Maity, A.E.(U), Sri Pradip Kr Chakraborty, SO, both are of (S&LP), Contai Division Office, along with Sri Indranil Maji, AE & SM, Bhagwanpur CCC, Sri Sounak Kar, LM Bhagwanpur CCC and others had been to the Vill: Haramasani, P.S-Bhagwanpur for routine inspection purpose. At first we went to the Agricultural premises Sri Sovaram Bhakta, S/O- Lt. Gorachand Bhakta of Vill: Haramasani, P.O- Paikvery, P.S-Bhagwanpur, Dist-Purba Medinipur and during inspection it was found that Sri Sovaram Bhakta, S/O- Lt. Gorachand Bhakta of Vill: Haramasani, consuming electricity unauthorisedly by way of direct hooking for bypassing the energy meter from the near by LT mains (i.e. from the nearby LT bushing of the Distribution Transformer) of WBSEDCLthrough 3 (three) nos single core blue colour PVC coated 1100/660 volt grade 10 sq mm aluminium conductor in respect of Consumer Id No: 223163363, Meter No: GX005178, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSEDCL in the tune of load 5.88 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of 3 (three) nos single core blue colour PVC coated 1100/660 volt grade 10 sq mm aluminium conductor of length 3 (three) meter each approx along with hooking device used to run the electrical appliances unauthorisedly for agricultural purpose were seized as a sample under memo of seizure list in presence of consumer and witnesses and duly signed by the witnesses butSri Sovaram Bhakta, S/O- Lt. Gorachand Bhaktarefused to signed on the Seizure List, Inspection Report. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer and witness and signature of witnesses obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 04:00 PM.

Thus Sri Sovaram Bhakta, S/O- Lt. Gorachand Bhakta of Vill: Haramasani, P.O- Paikvery, P.S-Bhagwanpur, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
