Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Shakti Pada Das, S/O- Lt Debendranath Das of Vill: Tethibari, P.O- Kismat Bajkul, P.S-Bhagwanpur, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 14.03.2017 at about 01:30 PM, I, Sri Manas Maity, A.E.(U), Sri Pradip Kr. Chakraborty, SO both are of (S&LP), Contai Division Office, along with Sri Indranil Maji, AE & SM, Bhagwanpur CCC, Sri Sounak Kar, LM Bhagwanpur CCC and others had been to the Vill: Tethibari, P.S-Bhagwanpur for routine inspection purpose. At first we went to the Domestic premises Sri Shakti Pada Das, S/O- Lt Debendranath Das of Vill: Tethibari, P.O- Kismat Bajkul, P.S-Bhagwanpur, Dist-Purba Medinipur and during inspection it was found that Sri Shakti Pada Das, S/O- Lt Debendranath Das of Vill: Tethibari, P.S-Bhagwanpur, Dist-Purba Medinipur consuming electricity dishonestly by way of direct hooking for bypassing the energy consumption through the energy meter unauthorisedly in respect of Consumer Id No: 200920801, Meter No: BR567950, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSEDCL in the tune of load 0.440 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some Portion of 2 (two) nos, separated single core white colour PVC coated 4 sq mm stranded copper conductor of length 2 (two) meter each approx along with hooking device as a sample used to run the electrical appliances for domestic purpose unauthorisedly were seized under memo of seizure list in presence of consumer and witnesses and duly signed by the witnesses. The consumer (accused) Sri Shakti Pada Das, S/O- Lt Debendranath Das of Vill: Tethibari was present during inspection but intentionally refused to sign on the seizure List, Inspection Report as well as in the label also. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer and witness and signature of witnesses obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 02:00 PM.

Thus Sri Shakti Pada Das, S/O- Lt Debendranath Das of Vill: Tethibari, P.O- Kismat Bajkul, P.S-Bhagwanpur, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
