Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Abhijit Gantait, S/O - Asit Baran Gantait, a permanent resident of Vill-Siulipur, P.O - Paschimbar, P.S -Bhagwanpur, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 07.04.2017 at about 01:30 PM I, Sri Indranil Maji, AE & SM, Bhagwanpur CCC along with Sri Sanjib Kr Mistri, LM Bhagwanpur CCC, Sri Biswanath Tudu, TSH Bhagwanpur CCC and others had been to the village- Siulipur for routine inspection purpose. During inspection it was found that Sri Abhijit Gantait was consuming electricity dishonestly in his Commercial (muri mill) premises unauthorisedly by way of direct hooking through single core faded red coloured PVC coated 7/22 SWG aluminium conductor from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 1.17 KVA.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of 1 (One) number single core faded red coloured PVC coated 7/22 SWG aluminium conductor of length 1 (Two) meter (approx) along with hooking device used to run the electrical appliances for Commercial purpose has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Abhijit Gantait acknowledged the same by putting his signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 02:00 PM.

Thus the accused Sri Abhijit Gantait, S/O - Asit Baran Gantait, Vill - Siulipur, P.O - Paschimbar, P.S -Bhagwanpur, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
