Sub: - Prayer for lodging a case against the arrested accused Sk Anarul @ Mousom (22 years) s/o Lt Sk Hossen of Pratapdighi, PS Pataspur, Dist Purba Medinipur under proper section of law.

Sir,

In producing herewith the arrested accused Sk Anarul @ Mousom (22 years) s/o Lt Sk Hossen of Pratapdighi, PS Pataspur, Dist Purba Medinipur along with seized articles and all relevant papers, I beg to submit that today on 04.01.17 Lt ASI Anil Kumar Yadav along with forces C/741 Swapan Kumar Ghorai and C/28 Sk Unus Mahammad were engaged in special raid duty vide Bhagwanpur PS GDE No. 141 Dated 04.01.2017 and CC No - 44/17 Dated - 04.01.2017. In course of the special raid duty received information over the telephone from unknown caller that, a person is selling ID liquor illegally in the resented at Bhimeswari Bazar to the local people in lieu of money. On receipt of this information myself along with force left for Bhimeswari Bazar and being directed by O/C Bhagwanpur PS held raid at 21:15 hrs in the market place of Bhimeswari Bazar and after a hot chase able to apprehend a person duly after disclosing our identity and cause of apprehension and called independent witnesses (1) C/741 Swapan Kumar Ghorai (2) C/28 Sk Unus Mahammad of Bhagwanpur PS. On asking the apprehended person he disclosed his identity as Sk Anarul @ Mousom (22 years) s/o Lt Sk Hossen of Pratapdighi, PS Pataspur, Dist Purba Medinipur and after a long interrogation able to seized (1) 10 liters Id Liquor (Cholai) containing in a plastic jar, valued approx 500/- (Five hundred only) (2) 04 (Four) Plastic Glasses in presence of above noted independent witnesses preparing seizure list duly signed by them and the apprehended person and labeled the same maintaining all norms and formalities and the apprehended person further stated that these was stored for the purpose of selling to the local people in lieu of money. On being asked the apprehended person failed to produce any valid documents or license in respect of the seized articles. The apprehended person violated the provision of 46 A (c) of Bengal excise act 1909. As such I taken him in custody preparing Memo of Arrest and seized the noted articles issued proper seizure list which was duly signed by the witnesses after collecting sample with proper label.

Hence I pray before you for lodging a case against the aforesaid arrested accused Sk Anarul @ Mousom (22 years) s/o Lt Sk Hossen of Pratapdighi, PS Pataspur, Dist Purba Medinipur under proper section of law.
