Sub: - Prayer for lodging a case against the arrested accused Sovan Ali Saha (25 years) s/o Jamsed Ali Saha of Vill Bhagwanpur, PS Bhagwanpur, Dist Purba Medinipur under proper section of law.

Sir

In producing herewith the arrested accused Sovan Ali Saha (25 years) s/o Jamsed Al-Saha of Vill Bhagwanpur, PS Bhagwanpur, Dist Purba Medinipur along with seized articles and all relevant papers, I beg to submit that today on 14.04.17 1, SI Biswaji Mondal along with forces C/ 812 Biswajit Kar and C/ 1579 Shibnath Murmu were engaged in evening mobile duty vide Bhagwanpur PS C.C No. 1090/17, Datec 14.04.17 In course of the evening mobile duty received source information from unknown caller that, a person is selling ID liquor illegally in his own tea shop at Bhagwanpur to the local people in lieu of money. On receipt of this information myself along with force left for Bhagwanpur and being directed by O/C Bhagwanpur PS held raid at 20:35 hrs, and after a hot chase able to apprehend a person duly after disclosing our identity and cause of apprehension and called independent witnesses Manoi Acharya, s/o Ghanashyam of Kotnouri, PS Bhagwanpur Dist Purba Medinipur and Narayan Ciri, s/o Mathan of Benudia PS Bhagwanpur Dist Purba Medinipur.On asking the apprehended person he disclosed his identity as Sovan Al-Saha (25 years) s/o Jamsed Ali Saha of Vill Bhagwanpur, PS Bhagwanpur, Dist Purba Medinipur and after a long interrogation able to seized (1) 10 liters ld Liquor (Cholai containing in a plastic jar, valued approx 500/-(Five hundred only) (2) 06 (Six Plastic Glasses from the near by place which was wrapped in a white nylon bag ir presence of above noted independent witnesses preparing seizure list duly signed by them and the apprehended person and labeled the same maintaining all norms and formalities and the apprehended person further stated that these was stored for the purpose of selling to the local people in lieu of money. On being asked the apprehended person failed to produce any valid documents or license in respect of the seized articles. The apprehended person violated the provision of 46 A (c) of Bengal excise act 1909. As such I taken him in custody preparing Memo of Arres and seized the noted articles issued proper seizure list which was duly signed by the witnesses after collecting sample with proper label.

Hence I pray before you for lodging a case against the aforesaid arrested accused Sovan Ali Saha (25 years) s/o Jamsed Ali Saha of Vill Bhagwanpur, PS Bhagwanpur. Disi Purba Medinipur under proper section of law.
