Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Mahesh Chandra Kuili, S/O- Lt Rampada Kuili of Vill: Dighanagar, P.O- Ektarpur, P.S-Bhagwanpur, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 17.04.2017 at about 01:05 PM, I, Sri Indranil Maji, AE & SM, Bhagwanpur CCC, along with Sri Sounak Kar, LM Bhagwanpur CCC, Sri Sanjib Kr Mistri, LM Bhagwanpur CCC and others, had been to the Vill: Dighanagar, P.S-Bhagwanpur for routine inspection purpose. At first we went to the Domestic premises Sri Mahesh Chandra Kuili, S/O- Lt Rampada Kuili of Vill: Dighanagar, P.O- Ektarpur, P.S-Bhagwanpur, Dist-Purba Medinipur and during inspection it was found that Sri Mahesh Chandra Kuili, S/O- Lt Rampada Kuili of Vill: Dighanagar, P.S-Bhagwanpur, Dist-Purba Medinipur consuming electricity unauthorisedly by way of direct hooking for meter bypassing through black colour P.V.C. coated 7/22 SWG stranded aluminium conductor of length 3 (three) meter (approx) along with hooking device in respect of Consumer Id No: 223171921, Meter No: L3113289, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSEDCL in the tune of load 1.760 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of 1 core round shape black colour P.V.C. coated 7/22 SWG stranded aluminium conductor of length 3 (three) meter (approx) along with hooking arrangement as a sample used to run the electrical appliances unauthorisedly for bypassing the energy consumption through the energy meter installed against Con Id-223171921 and one yellow card vide Sl No-016327 in the name of Mahesh Chandra Kuili were seized under memo of seizure list in presence of Sri Buddhadeb Kuili S/O Mahesh Chandra Kuili (son of accused) and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of the representative of consumer and witness and signature of witnesses and Sri Buddhadeb Kuili S/O Mahesh Chandra Kuili obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 01:30 PM.

Thus Sri Mahesh Chandra Kuili, S/O- Lt Rampada Kuili of Vill: Dighanagar, P.O- Ektarpur, P.S-Bhagwanpur, Dist-Purba Medinipur has committed an offence u/s 135 (i) (b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.




