Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Khokan Ghorai, S/O - Lt Sitaram Ghorai, a permanent resident of Vill-Anantapur, P.O -Naba Anantapur, P.S -Bhagwanpur, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 18.04.2017 at about 03:00 PM I, Sri Indranil Maji, AE & SM, Bhagwanpur CCC along with Sri Sanjib Kr Mistri, LM Bhagwanpur CCC, Sri Biswanath Tudu, TSH Bhagwanpur CCC and others had been to the village- Anantapur for routine inspection purpose. During inspection it was found that Sri Khokan Ghorai was consuming electricity dishonestly in his Domestic premises by way of direct hooking from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 0.5 KW.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and Some portion of black coated PVC cable, length 2 meter approx along with hooking device used to run his electrical appliances for domestic purpose, from the L.T.O.H line of W.B.S.E.D.C.L has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. The above seized materials duly packed and labeled at the inspection site and signature of witnesses has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 3:30PM.

Thus the accused Sri Khokan Ghorai, S/O - Lt Sitaram Ghorai, Vill - Anantapur, P.O -Naba Anantapur, P.S -Bhagwanpur, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
