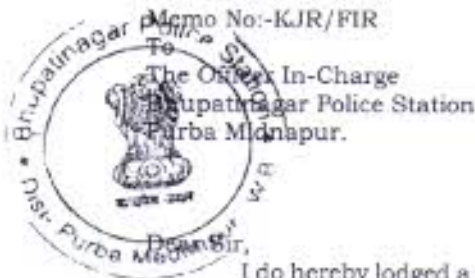

I do hereby lodged a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Smt. Sadhana Das, W/O- Sri Bishnupada Das of Vill: & P.O- Garbari, P.S-Bhupatinagar, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 17.01.2017 at about 02:00 PM, I, Sri Manas Maity, A.E.(U), Sri Pradip Kr. Chakraborty, SO, both are of (S&LP), Contai Division Office, along with Sri Sagar Kandar, LM Khejuri CCC and Sri Gokul Ch. Mondal, Hg Sr LM of Khejuri CCC had been to the Vill: Garbari, P.S-Bhupatinagar for routine inspection purpose. At first we went to the Domestic premises of Smt. Sadhana Das, W/O- Sri Bishnupada Das of Vill: & P.O- Garbari, P.S-Bhupatinagar, Dist-Purba Medinipur and during inspection it was found that Smt. Sadhana Das, W/O- Sri Bishnupada Das of Vill: Garbari consuming electricity unauthorisedly by way of bypassing the energy meter by tempering the incoming service cable in respect of Consumer Id No: 200233828, Meter No: L1353374, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSEDCL in the tune of load 0.71 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of 2 core round shaped black colour PVC coated 4 sq mm tampered service cable of length 2 (two) meter approx alongwith bypass arrangemant made by another blue colored PVC coated stranded (LAN Cable) of length 2 feet approx used to run the electrical appliances unauthorisedly for domestic purpose and one yellow card vide SL NO 1161916 in the name of Smt. Sadhana Das were seized under memo of seizure list in presence of consumer and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer and witness and signature of witnesses and consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 02:30 PM.

Thus Smt. Sadhana Das, W/O- Sri Bishnupada Das of Vill: & P.O- Garbari, P.S-Bhupatinagar, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
