Sir,

In producing herewith two arrested accused namely i) Bhola Das (21) S/O- Shyam Das, ii) Laxman Das @ Laccha Das (20) S/O- Krishna Das all of vill+P.O- Purbacot PS- Karai Dist- Jujpur, State- Orisa and the following article under proper seizure list. I ASI N. G. Deb do hereby lodge complain that on 17-18.01.17 night when myself along with C/219- Joydeb Saha, C/956- Bobby Singh on night patrolling duty on NH 116 B vide Bhupatinagar PS CC No- 101/17 Dt- 17.01.17 received information from source that some persons assemble at Bajkul near traffic post behind a fruit shop. They might have plain to commit Dacoity. On received the information I inform duty officer SI P.K. Ghosh to make a G.D.E vide BPN PS GDE No- 535 dated- 18.01.17 and also informed OC Bhupatinagar PS .

Accordingly myself as per order of OC Bhupatinagar reached Bajkul and keeping vehicle at safe distance move to towards assemble point on foot. From considerable distance notice that some persons were behind the fruit shop and they were noticed whispering. Light of torch was also found. Accordingly we surrounded them from three sides. On scent of police they started running but we could apprehend two of them with dagger, sword etc. we chased others but they manage to escape. After apprehend myself and force disarmed them. During interrogation they disclose their identity as i) Bhola Das (21) S/O- Shyam Das, ii) Laxman Das @ Laccha Das (20) S/O- Krishna Das all of vill+P.O- Purbacot PS- Karai Dist- Jujpur, State- Orisa and also disclose that they were 05 in numbers and also stated the name of **i)** Biswajit @ Akash Diyasi of Khanjadapur **ii)** Ratan Barman Of Garbari **iii)** Nishikanta @ Kochi Singha of Biribari all PS Bhupatinagar as their associate. They disclosed that Bisojit @ Akash is their gang leader, they committed crime against property in Orisa before. I searched them and seized the weapon from their respective possession as follows.

From possession of Bhola Das (21) S/O- Shyam Das seized **i)** One black color plastic toy pistol, **ii)** Approximately 15' green nylon rope, **iii)** One dagger about 9" length, **iv)** One numberless Black Blue Pulser Motor Cycle.

From possession of Laxman Das @ Laccha Das (20) S/O- Krishna Das seized **i)** One iron rod of 4' Length, **ii)** One sword of 4' length, **iii)** One two cell old torch.

I like to note that due dead hour of night no shop keeper or common people were found on spot. Hence I arrested both accused persons after observing all pre -during and post arrest formality. Prepare memo of arrest and seizure list. Copy supplied to them. Under the circumstance it is crystal clear that the accused persons assembled at Bajkul to commit Dacoity but luckily apprehended.

I therefore pray a case under proper section of law may kindly be stated against **i) Bhola Das (21) S/O- Shyam Das ii) Laxman Das @ Laccha Das (20) S/O- Krishna Das iii) Biswajit @ Akash Diyasi iv) Ratan Barman v) Nishikanta @ Kochi Singha** and arrange for investigation.
