Dear Sir,

I do hereby lodged a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Haripada Maity, S/O- Lt Hiralal Maity of Vill- Uttarchak, P.O-Sukurullapur, P.S-Bhupatinagar, Dist-Purba Midnapur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 18.01.2017 at about 11-00 AM, I, Sri Rabi Sankar Bera, A.E & S.M, Madhakhali CCC along with Sri Anup Kr Das, L.M of Madhakhali C.C.C. and Sri Nilkantha Paul, L.M of Madhakhali C.C.C inspected the Agricultural Premises of Sri Haripada Maity, S/O- Lt Hiralal Maity of Vill- Uttarchak, P.O-Sukurullapur, P.S-Bhupatinagar, Dist-Purba Midnapur which is situated at Mouza- Uttarchak. During inspection it was found that Sri Haripada Maity, S/O- Lt Hiralal Maity of Vill- Uttarchak, P.O-Sukurullapur, P.S-Bhupatinagar, Dist-Purba Midnapur bearing Consumer Id No: 223150532, Meter No: RSX52549 was consuming Electricity unauthorizedly by way of direct hooking from L.T bushing of Dist. Transformer for bypassing the meter in view of less recording of energy units in the meter, causing loss of revenue to WBSIEDCL at the tune of load 5.88 KVA for Agriculture purpose for his wrong full gain.

As theft of electricity was detected during the inspection the service connection was disconnected and some portion of three core Black coated PVC cable with hooking device two meter (approx) was seized under memo of seizure list in the presence of the witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of witness and signature of witnesses obtained on the label. Also prepared inspection report at the inspection site. After completion of inspection the inspection team left the aforesaid premises at about 11.30 AM.

Thus Sri Haripada Maity, S/O- Lt Hiralal Maity of Vill- Uttarchak, P.O-Sukurullapur, P.S-Bhupatinagar, Dist-Purba Midnapur committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain & treat it as FIR.
