Sir,

In producing herewith one arrested accused person named Bhim Jana(51y) S/O- Lt. Prafullya Jana of vill- Ramchak, P.S- Bhupatinagar, Dist- Purba Medinipur, along with the following seized articles.

1. 05 liters of I/D liquor in a plastic jaricane.
2. 02 bottles of Country Spirit, each containing 600 ml.
3. Approx 375 ml of I/D liquor, taken from the 05 liters I/D liquor filled jaricane, (as noted in SI No-1) for it's chemical examination at FSL.

(The total approximate value of the seized articles are Rs:-250/-)

The fact of the case in brief is that, ASI Debdulal Maity, while performing special raid duty, and evening mobile duty, as per superiors order, along with force (C/-1143 Prosenjit Malo , C/701 Ajit Kr. Karan, NVF- Sankar Nanda) vide GDE No-622, Dt:-19/01/17), received a secret source information at approx 19:15 hrs, that one person named Bhim Jana(51y) S/O- Lt. Prafullya Jana of vill- Ramchak,, P.S- Bhupatinagar, Dist- Purba Medinipur, is selling I/D liquor, and country spirit, unauthorized and illegally at vill Ramchak, under Bhupatinagar P.S. So myself along with force rushed to the Ramchak, to work out the information and arrived at the Ramchak, at approx 20:15 hrs, and detain the, Bhim Jana(51y) S/O- Lt. Prafullya Jana of vill- Ramchak, P.S- Bhupatinagar, Dist- Purba Medinipur, at Ramchak, as identified by the secret source, upon search the above noted I/D liquor, country spirit , has been found from the exclusive possession of the Bhim Jana then I asked him to produce the authority or license in support of his possession of above stated I/D liquors and Country Spirit, but he failed to show any, he also confessed his guilt before me, in that circumstances I arrested Bhim Jana under proper arrest memo, and seized the above mentioned articles under proper seizure list duly signed by the police witness and local public person, is turned up on request. Approx 375ml of I/D liquor taken in a bottle , from the above noted 05 liters of I/D liquor filled jaricane (noted in SL No-1) , for it's chemical examination at FSL, has also been seized under proper seizure list. Proper sealing, packaging , and labeling of the seized articles has been made, upon asked the, Bhim Jana who possessed the above noted articles discloses his name and address , as Bhim Jana(51y) S/O- Lt. Prafullya Jana of vill- Ramchak, P.S- Bhupatinagar, Dist- Purba Medinipur, . So I brought Bhim Jana to the PS under arrest ,along with the seized articles, and lodged a complain against him before the O.C Bhupatinagar P.S.

So I pray a specific case may kindly be started against the accused Bhim Jana(51y) S/O- Lt. Prafullya Jana of vill- Ramchak, P.S- Bhupatinagar, Dist- Purba Medinipur, under proper section of law.
