I, C/D 1403 Arunava Ghosh beg to state that today on 24.01.17 at about 05.30 hrs as per instruction of O.C Mandarmoni Costal PS along with him and C/Anarul Hussaian Gaji, going to Tamluk to attended Crime Conference of S.P. Purba Medinipur by PS Govt. vehicle bearing No- WB 24Y/6994 (Bolero)

On the way at Bajkul, infront of Janakallayan High School, found one truck coming from Chandipur side, being rash and negligently driven by it's driver, allowing us a very narrow space. The road was extremely foggy for which I could not see the truck from far, nor I can read the number plate of the said truck. To avert accident I tried hard but due to heavy fog our Govt. Vehicle having Reg. no- WB 24Y/6994 (Bolero)became upside down and got badly damaged.

SI Rajkumar Debnath, O.C Mandarmani Costal PS and C/Anarul Hussaian Gaji sustained injury on their person.

So, I pray a specific case may kindly be started under proper section of law against unknown truck driver who could not be traced at the moment..
