Dear Sir,
I do hereby lodged a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Susanta Maity, S/O- Bijoy Krishna Maity of Vill- Uttar Digha, P.O- Itaberia, P.S-Bhupatinagar, Dist-Purba Midnapur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 27.01.2017 at about 09-30 AM, I, Sri Rabi Sankar Bera, A.E & S.M; Madhakhali CCC along with Sri Barun Mandal, T.S.H of Madhakhali C.C.C. and Sri Nilkantha Paul, L.M of Madhakhali C.C.C inspected the Agricultural Premises of Sri Susanta Maity, S/O- Bijoy Krishna Maity of Vill- Uttar Digha, P.O-Itaberia, P.S-Bhupatinagar, Dist-Purba Midnapur which is situated at Mouza- Madhakhali. During inspection it was found that Sri Susanta Maity, S/O- Bijoy Krishna Maity of Vill- Uttar Digha, P.O- Itaberia, P.S-Bhupatinagar, Dist-Purba Midnapur consuming Electricity unauthorizedly by way of direct hooking from nearest L.T.O.H Line for running his Agricultural Pump Set, causing loss of revenue to WBSEDCL at the tune of load 1.76 KVA for Agriculture purpose for his wrong full gain.

As theft of electricity was detected during the inspection the service connection was disconnected and some portion of single core white & blue coated PVC wire with hooking device two meter (approx) each were seized under memo of seizure list in the presence of the witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of witness and signature of witnesses obtained on the label. Also prepared inspection report at the inspection site. After completion of inspection the inspection team left the aforesaid premises at about 09-45 AM.

Thus Sri Susanta Maity, S/O- Bijoy Krishna Maity of Vill- Uttar Digha, P.O-Itaberia, P.S-Bhupatinagar, Dist-Purba Midnapur committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain & treat it as FIR.
