Dear Sir,

I do hereby lodged a written complaint empowered by the Electricity Act 2003 and its Amendment Act 2007 against Sri Bibhas Das, S/O- Lt Gourishankar Das of Vill- Madhakhali, P.O- Bhupatinagar, P.S-Bhupatinagar, Dist-Purba Midnapur has committed theft of Electricity u/a 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder:

On 27.01.2017 at about 10-45 AM, I, Sri Rabi Sankar Bera, A.E & S.M, Madhakhali C.C.C along with Sri Barun Mandal, T.S.H of Madhakhali C.C.C and Sri Nitanta Paul, T.M of Madhakhali C.C.C inspected the Agricultural Premises of Sri Bibhas Das, S/O- Lt Gourishankar Das of Vill- Madhakhali, P.O-Bhupatinagar, P.S-Bhupatinagar, Dist-Purba Midnapur which is situated at Manu- Madhakhali. During inspection it was found that Sri Bibhas Das, S/O- Lt Gourishankar Das of Vill- Madhakhali, P.S- Bhupatinagar, P.S-Bhupatinagar, Dist-Purba Midnapur bearing Consumer ID No. 201454948, Meter No. IX005066 was consuming Electricity unauthorizedly by way of direct tapping from neutral L.T.O.H Line by bypassing the meter in view of less recording of energy units in the meter, causing loss of revenue to WBSEDCL at the tune of load 4.38 KVA for Agriculture purpose for his wrong full gain.

As theft of electricity was detected during the inspection the service connection was disconnected and some portion of single core white & black coated 3 nos PVC wire with hooking device two meter (approx) each were seized under memo of seizure list in the presence of the witnesses and duly signed by them. Thereafter the seized articles were packed and labeled as the inspection site in presence of witnesses and signature of witnesses obtained on the label. Also prepared inspection report as the inspection was completed. After completion of inspection the inspection team left the aforesaid premises at about 11:15 AM.

Thus Sri Bibhas Das, S/O- Lt Gourishankar Das of Vill- Madhakhali, P.O- Bhupatinagar, P.S- Bhupatinagar, Dist-Purba Midnapur committed an offence u/a 135 (a) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complaint and issue an FIR.
