I do hereby lodged a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Rabindranath Mondal (User), S/O- Lt. Niranjan Mondal of Vill- Garbari, P.S- BhupatiNagar, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 01.03.2017 at about 11:35 AM, I Prashanta Biswal, AE & SM, Khejuri CCC along with Sourabh Santara, SAE, Sagar Kandar, LM Khejuri CCC and others had been to the Vill- Garbari, P.S- BhupatiNagar for routine inspection purpose. At first we went to the Domestic premises of Rabindranath Mondal (User), S/O- Lt. Niranjan Mondal of Vill-Garbari, P.S- BhupatiNagar and during inspection it was found that Rabindranath Mondal (User), S/O- Lt. Niranjan Mondal consuming electricity unauthorisedly by the way of bypassing of energy meter for less recording of energy units into the meter causing loss of revenue to WBSEDCL at the tune of load 0.71 KVA. One energy meter is already installed vide Consumer Id No: 200232673, Meter No: L1350206 in the name of Niranjan Mondal, Vill- Garbari.

As theft of electricity was detected during the inspection the connection was disconnected from pole and some portion of two core Black coloured PVC coated 6 sq mm service main of length 2 (Two) meters (approx) alongwith single core 2.5 sqmm PVC Coated black colored bypassing wire were seized under memo of seizure list in presence of witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of witnesses and signatures of witnesses obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 12:05 PM.

Thus Rabindranath Mondal (User), S/O- Lt. Niranjan Mondal of Vill- Garbari, P.S-BhupatiNagar, Dist- Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.
