Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Nonigopal Bera, S/O- Lt Siba Prasad Bera of Vill: Jukhia, P.O- Jukhia Bazar, P.S- Bhupatinagar, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 15.03.2017 at about 12:00 PM (Noon), I, Sri Manas Maity, A.E.(U), (S&LP), Contai Division Office, along with Sri Rabi Sankar Bera, AE & SM, Madhakhali CCC, Sri Nilkantha Paul, LM Madhakhali CCC and others had been to the Vill: Jukhia, P.S-Bhupatinagar for routine inspection purpose. At first we went to the Agriculture premises Sri Nonigopal Bera, S/O- Lt Siba Prasad Bera of Vill: Jukhia, P.O- Jukhia Bazar, P.S-Bhupatinagar, Dist-Purba Medinipur and during inspection it was found that Sri Nonigopal Bera, S/O- Lt Siba Prasad Bera of Vill: Jukhia, P.S-Bhupatinagar, Dist-Purba Medinipur consuming electricity unauthorisedly by way of direct hooking for meter bypassing in respect of Consumer Id No: 200521130, Meter No: YX013276, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSSEDCL in the tune of load 4.380 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of 4 (four) nos. separated single core with 2 (two) white, 1 (one) no blue and 1 (one) black colour PVC coated aluminium conductor of length 2 (two) meter each approx along with hooking device used to run the agricultural pump-motor set unauthorisedly were seized as a sample under memo of seizure list in presence of consumer and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer and witness and signature of witnesses and consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 12:30 PM.

Thus Sri Nonigopal Bera, S/O- Lt Siba Prasad Bera of Vill: Jukhia, P.O- Jukhia Bazar, P.S- Bhupatinagar, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
