Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Bankim Bar @ Bankim Chandra Bar, S/O- Lt. Harekrishna Bar, a permanent resident of Vill- Purulia, P.O-Bamonbar, P.S-Bhupatinagar, Dist-Purba Midnapur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 15.05.2017 at about 02-00 PM, I, Sri Manas Maity, A.E (U), and Sri Pradip Kr Chakraborty both are of S&LP unit of Contai Division along with Sri Sayan Chatterjee, SAE (E) Madhakhali CCC and Sri Nilkantha Paul, L.M of Madhakhali CCC and others inspected the Commercial Fishery Premises of Sri Bankim Bar @ Bankim Chandra Bar, S/O- Lt. Harekrishna Bar situated at Vill & PO- Arjunnagar, under P.S-Bhupatinagar. During inspection it was found that Sri Bankim Bar @ Bankim Chandra Bar, S/O- Lt. Harekrishna Bar of Vill- Purulia, P.O-Bamonbar, P.S-Bhupatinagar, Dist-Purba Midnapur consuming Electricity unauthorisedly by way of direct hooking from nearest LTOH Line for running his Commercial Pump Set, causing loss of revenue to WBSEDCL at the tune of load 1.17 KVA for Commercial (Fishery) purpose for his wrong full gain.

As theft of electricity was detected during the inspection the illegal hooking line was disconnected and removed from our LTOH line of WBSEDCL and some portion of single core stranded yellow colour PVC coated 7/16 SWG conductor along with hooking device of length 2 (two) meter (approx) as a sample was seized under memo of seizure list in the presence of the witnesses and duly signed by them. During inspection Sri Bankim Bar @ Bankim Chandra Bar, S/O- Lt. Harekrishna Bar was present at the site and acknowledged the same by putting his signature on the Seizure List, Inspection Report as well as on the Label also. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer & witness and signature of both consumer & witnesses obtained on the label. Undersigned also prepared inspection report at the inspection site. After completion of inspection the inspection team left the aforesaid premises at about 02-30 PM.

Thus Sri Bankim Bar @ Bankim Chandra Bar, S/O- Lt. Harekrishna Bar of Vill- Purulia, P.O-Bamonbar, P.S-Bhupatinagar, Dist-Purba Midnapur committed an offence u/s 135 (i)(a) of the Electricity Act 2003 read with Amendment Act 2007.
