Dear Sir,

I do hereby lodged a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Malay Maity, S/O- Late Jugal Maity of Vill- Goramulda, P.S- Bhupatinagar, Dist- Purba Midnapur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 18.05.2017 at about 10-40 AM, I, Sri Rabi Sankar Bera, A.E. & Station Manager, Madhakhali Customer Care Centre along with Sri Nilkantha Paul, L.M of Madhakhali C.C.C and Sri Anup Kumar Das, L.M, Madhakhali CCC entered in to the Commercial (fishery) premises of Sri Malay Maity, S/O- Late Jugal Maity of Vill- Goramulda, P.S- Bhupatinagar, Dist- Purba Midnapur for inspection of electrical installation. During inspection it was found that Sri Malay Maity, S/O- Late Jugal Maity of Vill- Goramulda, P.S- Bhupatinagar, Dist- Purba Midnapur consuming electricity unauthorizedly by way of direct hooking from our nearest L&MV source for run his fishery, causing loss of revenue to WBSEDCL in the tune of load 1 KVA for his wrongful gain.

As theft of electricity was detected during the inspection the hooking wire was disconnected & dismeling from L.T Line and some portion of single core black coated PVC wire with hooking device two meter (approx) was seized under memo of seizure list in presence of witnesses and duly signed by them. Thereafter the seized articles was packed and labeled at the inspection site and signature of witnesses obtained on the label. Also I prepared inspection report at the inspection site. Interrogated the consumer about this theft and subsequently he admitted his guilt. After completion of inspection, the inspection team left the aforesaid premises at 10-55 AM.

Thus Sri Malay Maity, S/O- Late Jugal Maity of Vill- Goramulda, P.S- Bhupatinagar, Dist- Purba Midnapur has committed an offence u/s 135 (i)(a) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain & treat it as FIR.
