Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Tapas Sau, S/O - Lt Purnendu Sau, a permanent resident of Vill- & P.O -Garbari, P.S -Bhupatinagar, Dist. - Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated here under.

On 01.06.2017 at about 02:30 PM I, Sri Manas Maity, A.E.(U), Sri Pradip Kr Chakraborty, SO both are of (S&LP) unit Contai Division Office along with Sri Prasantha Biswal, AE & SM Khejuri CCC, Sri Sourabh Santara, SAE (E) Khejuri CCC, Sri Hari Pada Das, Gr-I TSH, Khejuri CCC and others had been to the village- Garbari for routine inspection purpose. During inspection it was found that Sri Tapas Sau was consuming electricity dishonestly in his Domestic premises unauthorisedly by way of direct hooking from the nearby LTOH line of WBSEDCL through 2 core black colour PVC coated flat type 4 sq mm aluminium conductor, causing considerable loss of revenue of WBSEDCL to the tune of load 1.17 KVA.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of 2 core black colour PVC coated flat type 4 sq mm aluminium conductor of length 4.5 (four & half) meter approx along with hooking device used to run the electrical appliances by the way direct hooking from the near by LTOH line of WBSEDCL has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Tapas Sau refused to sign in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 03:00 PM.

Thus the accused Sri Tapas Sau, S/O - Lt Purnendu Sau, Vill - Garbari, P.O - Garbari, P.S -Bhupatinagar, Dist.- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
