I do hereby lodged a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Ranjan Maity, S/O- Haripada Maity of Vill- Gholbagda, P.S- Bhupatinagar, Dist-Purba Midnapur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 03.06.2017 at about 11-00 AM, I, Sri Rabi Sankar Bera, A.E. & Station Manager, Madhakhali Customer Care Centre along with Sri Nilkantha Paul, L.M of Madhakhali C.C.C and Sri Anup Kumar Das, L.M, Madhakhali CCC entered in to the Commercial (fishery) premises of Sri Ranjan Maity, S/O- Haripada Maity of Vill- Gholbagda, P.S-Bhupatinagar, Dist-Purba Midnapur for inspection of electrical installation vide Consumer Id No: 201973823, Meter No: B4024189. During inspection it was found that Sri Ranjan Maity, S/O- Haripada Maity of Vill- Gholbagda, P.S-Bhupatinagar, Dist-Purba Midnapur consuming electricity unauthorizedly by way of direct hooking from our nearest L&MV source for run his fishery for bypassing the meter, causing loss of revenue to WBSSEDCL in the tune of load 1.17 KVA for his wrongful gain.

As theft of electricity was detected during the inspection the service connection was disconnected & dismeling hooking wire from L.T Line and some portion of single core blue coated PVC wire with hooking device ten meter(approx) was seized under memo of seizure list in presence of witnesses and duly signed by them. Thereafter the seized articles was packed and labeled at the inspection site and signature of witnesses obtained on the label. Also I prepared inspection report at the inspection site. Interrogated the consumer about this theft and subsequently he admitted his guilt. After completion of inspection the inspection team left the aforesaid premises at 11-40 AM.

Thus Sri Ranjan Maity, S/O- Haripada Maity of Vill- Gholbagda, P.S-Bhupatinagar, Dist-Purba Midnapur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain & treat it as FIR.
