Dear Sir,

I do hereby lodged a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Narayan Bera, S/O- Lt. Parameswar Bera of Vill- Rasiknagar, P.S- Bhupatinagar, Dist-Purba Midnapur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 13.06.2017 at about 10-30 AM, I, Sri Rabi Sankar Bera, A.E & S.M, Madhakhali CCC along with Sri Anup Kumar Das, L.M, Madhakhali C.C.C and Sri Nilkantha Paul, L.M of Madhakhali C.C.C. had been to the Vill: Rasiknagar, P.S-Bhupatinagar for inspection purpose. At first we went to the Industrial premises of Sri Narayan Bera, S/O- Lt. Parameswar Bera of Vill- Rasiknagar, P.S-Bhupatinagar, Dist-Purba Midnapur. During inspection it was found that Sri Narayan Bera, S/O- Lt. Parameswar Bera of Vill- Rasiknagar, P.S-Bhupatinagar, Dist-Purba Midnapur consuming electricity unauthorizedly by way of direct hooking from L.T bushing of Dist. Transformer for run his Industrial motor, causing loss of revenue to WBSEDCL in the tune of load 13.16 KVA. The said consumer Sri Narayan Bera was running a Husking Mill for business purpose.

As theft of electricity was detected during the inspection the hooking wire dismantled from L.T bushing of the Dist. Transformer after getting proper shut down and some portion of single core white coated three nos PVC wire with hooking device of 05 meter(approx)each were seized under memo of a seizure list in the presence of the consumer's representative and witnesses and signature of witness and consumer's representative obtain on the Seizer list. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer's representative and witness and signature of witness was duly obtained on the label. Also I prepared inspection report at the inspection site. Interrogated the consumer's representative about this theft and subsequently he admitted his guilt. After completion of inspection the inspection team left the aforesaid premises at 11-15 AM.

Thus Sri Narayan Bera, S/O- Lt. Parameswar Bera of Vill- Rasiknagar, P.S-Bhupatinagar, Dist-Purba Midnapur has committed an offence u/s 135 (i)(a) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain & treat it as FIR.
