Debdulal Maity beg to state that at 19.05 hrs. during my mobile duty (vide Bhupatinagar P.S CC No- 724/17 dt- 17.06.17) receive an information from SI Sukesh Ch. Adhikary of Bhupatinagar P.S, that one Sukesh Pal of near Bayenda Bazar, engaged in selling Foreign liquor and country Spirit from his resident.

After getting the information, with a view to work out the same myself with C/259 Mantu Malik, C/1134 Biswajit Das, C/1554 Manik Kuila, C.V Uttam Manna proceeded towards Bayenda. When we reach near house of Sukesh Pal found that some youths are engaged in purchasing liquor. On sight of police all fled away in darkness.

In presence of Laxmi Pal W/O Sukesh Pal, we entered in the house of sukes pal, who is found absent. We searched room and found the above noted amount of liquor are kept stored for selling which is unauthorized in nature. Nor Laxmi Pal could produce any authority or any document for selling the same.

In presence of witnesses I seized the above noted bottles and prepared seizure list duly signed by the witnesses.

I therefore pray that a cog case may kindly be initiated against Sukesh Pal S/O- Lt. Chittaranjan Pal for committing the crime of unauthorized selling of liquor
