Dear Sir,

I do hereby lodged a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Subhas Samanta, S/O- Late Kumed Ch. Samanta of Vill- Bahadurpur, P.O- Bahadurpur, P.S-Bhupatinagar, Dist-PurbaMidnapur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 24.06.2017 at about 11-10 AM, I, Sri Rabi Sankar Bera, A.E & S.M, Madhakhali CCC along with Sri Anup Kumar Das, L.M, Madhakhali CCC and Sri Nilkantha Paul, L.M of Madhakhali C.C.C had been to the Vill- Bahadurpur, P.O- Bahadurpur, P.S-Bhupatinagar for inspection purpose. At first we went to the Domestic premises of Sri Subhas Samanta, S/O- Late Kumed Ch. Samanta of Vill- Bahadurpur, P.O- Bahadurpur, P.S-Bhupatinagar, Dist-Purba Midnapur bearing Con Id No: 223091991, Meter No: L4426958. During inspection it was found that Sri Subhas Samanta, S/O- Late Kumed Ch. Samanta of Vill- Bahadurpur, P.O- Bahadurpur, P.S-Bhupatinagar, Dist-PurbaMidnapur consuming electricity unauthorizedly by way of bypassing the meter by tempering incoming service cable for less recording of meter units, causing loss of revenue to WBSEDCL in the tune of load 0.80 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of two core black coated PVC in coming service cable with tapping single core black coated pvc wire approx length 1 Mtr was seized under memo of a seizure list in presence of the witnesses and duly signed by them. Thereafter the seized articles was packed and labeled at the inspection site in presence of witnesses and signature of witnesses obtained on the label. Also I prepared inspection report at the inspection site. Interrogated the consumer's representative about this theft and subsequently he admitted his guilt. After completion of inspection the inspection team left the aforesaid premises at 11-50 AM.

Thus Sri Subhas Samanta, S/O- Late Kumed Ch. Samanta of Vill- Bahadurpur, P.O- Bahadurpur, P.S-Bhupatinagar, Dist-Purba Midnapur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain & treat it as FIR.
