I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Pralad Giri, S/O- Lt Rajendra Nath Giri of Vill- Uttar Digha, P.O-Itaberia, P.S-Bhupatinagar, Dist-Purba Midnapur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 01.04.2017 at about 11-05 AM, I, Sri Rabi Sankar Bera, A.E & S.M, Madhakhali CCC along with Sri Nilkantha Paul, L.M of Madhakhali C.C.C Sri Anup Kumar Das, L.M of Madhakhali C.C.C inspected the Agricultural Premises of Sri Pralad Giri, S/O- Lt Rajendra Nath Giri of Vill- Uttar Digha, P.O-Itaberia, P.S-Bhupatinagar, Dist-Purba Midnapur which is situated at Mouza- Uttar Digha. During inspection it was found that Sri Pralad Giri, S/O- Lt Rajendra Nath Giri of Vill- Uttar Digha, P.O-Itaberia, P.S-Bhupatinagar, Dist-Purba Midnapur bearing Consumer Id No: 200812631, Meter No: RSX90994, was consuming Electricity unauthorizedly by way of direct hooking from LT bushing of Dist Transformer for bypassing the meter in view of less recording of energy units in the meter , causing loss of revenue of WBSEDCL at the tune of load 4.38 KVA for Agriculture purpose for his wrong full gain.

As theft of electricity was detected during the inspection the service connection was disconnected and some portion of single core black coated three nos PVC wire with hooking device of two meter (approx) each were seized under memo of seizure list in presence of witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of witness and signature of witnesses obtained on the label. Also prepared inspection report at the inspection site. After completion of inspection the inspection team left the aforesaid premises at about 11-55 AM.

Thus Sri Pralad Giri, S/O- Lt Rajendra Nath Giri of Vill- Uttar Digha, P.O-Itaberia, P.S-Bhupatinagar, Dist-Purba Midnapur committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain & treat it as FIR.
