Sub: - Prayer for lodging a case against the arrested accused Tapan Bera (35 years) s/o Late Pulin Ch. Bera of Vill Purba Sarberia, Post Narayandari, PS Bhagwanpur, Dist Purba Medinipur u/s 46A(c) BE Act.

Sir,

In producing herewith one arrested accused Tapan Bera (35 years) s/o Late Pulin Ch. Bera of Vill Purba Sarberia, Post Narayandari, PS Bhagwanpur, Dist Purba Medinipur along with seized articles and all relevant papers, I SI Naba Kumar Rajwar of Bhagwanpur PS, beg to submit that today on 17.12.2016 myself along with forces C/ 647 Sricharan Maji and C/ 1261 Hemanta Murmu was engaged in evening mobile duty vide Bhagwanpur PS GDE No. 784 dated 17.12.2016 and CC No. 6368 dated 17.12.2016. During my mobile duty, I received a secret & reliable source information at 18:35 hrs on 17.12.16 that a person is selling ID liquor illegally in his own Tea shop at Purba Sarberia Bazar to the local people in lieu of money. On receipt of this information myself informed the matter to O/C Bhagwanpur PS and as instructed I along with forces left for Purba Sarberia Bazar to work out the information. At 19:25 we reached at Purba Sarberia Bazar and as shown by my source, I searched the tea shop of Tapan Bera after disclosing our identity and in presence of witnesses namely (1) Subimal Maity, S/O- Late Pran Krishna Maity of Sarberia, PS- Bhagwanpur, Dist- Purba Medinipur and (2) Sankar Bera, S/O- Arjun Bera of Bhabanichak, PS- Bhagwanpur, Dist- Purba Medinipur. After search I seized (1) Approx 07 liters of Id Liquor (Cholai) containing in a plastic jar, valued approx 350/-(Rupees Three hundred fifty only) and (2) 04 (Four) Plastic Glasses from possession of Tapan Bera in presence of above noted independent witnesses. Prepared seizure list duly signed by them and the apprehended person and labeled the same maintaining all norms and formalities and the apprehended person further stated that these was stored for the purpose of selling to the local people in lieu of money. On being asked he failed to produce any valid documents or license in respect of the seized articles. Accordingly I arrested Tapan Bera (35 years) s/o Late Pulin Ch. Bera of Vill Purba Sarberia, Post Narayandari, PS Bhagwanpur, Dist Purba Medinipur as he violated provision of 46A(c) of Bengal Excise act 1909.

Hence I pray before you for lodging a case against the aforesaid arrested accused Tapan Bera [35] years) s/o Late Pulin Ch. Bera of Vill Purba Sarberia, Post Narayandari,PS Bhagwanpur, Dist Purba Medinipur under 46A(c) BE Act.
