Dear Sir,

I, do hereby lodge a complaint empowered by enabling the Electricity Act 2003 (with Amendment Act 2007) to the effect that Sri. Khudiram Maity S/o. Lt. Atul Maity Village: Kadamtala P.O. Kandapasra, P. S. Chandipur, Dist: Purba Medinipur, have committed an offence of theft of electricity u/s 135 of Electricity Act 2003 with Amendment Act 2007 as stated here under.

On dated 25/01/2017 at about 12:15 PM I, Sri Tanmoy Saha, Assistant Engineer and Station Manager, Chandipur Customer Care Centre WBSEDCL along with

- 1) Sankar Kumar Biswas, SAE(E) Chandipur Customer Care Centre, WBSEDCL and
- 2) Dipak Sinha, LM, Chandipur Customer Care Centre, WBSEDCL

entered into the agricultural premises owned by Sri Khudiram Maity S/o. Lt. Atul Maity Village: Kadamtala P.O. Kandapasra, P. S. Chandipur, Dist: Purba Medinipur, and detected that he was consuming electricity dishonestly by directly hooking from L.T OH with a tune of load 2 KVA for Agricultural purpose, causing theft of power and loss of revenue of WBSEDCL.

As theft of Electricity was detected during the inspection, Some portion of 2 wire PVC cable of length 3 metres approx. with hooking devices used for theft of electricity was removed and seized the same under a memo of seizure list in the presence of respective witnesses and their signature also obtained on the seizure list. The above seized materials were packed, sealed and labeled at the inspection site and the signature of the witnesses also obtained on the sealing label.

Thus the above mentioned accused persons, Sri. Khudiram Maity S/o. Lt. Atul Vill. Kadamtala P. O. Kandapasra, P. S. Chandipur, Dist: Purba Medinipur, have committed an offence under section 135(1)(a) of the Electricity Act 2003 (with Amendment Act 2007). Under this circumstances you are requested to take cognizance of this complain and treat the same as FIR against above mentioned person accordingly.
